In case any of the students fails to deposit his/her prescribed fees by **27<sup>th</sup> February, 2024**, the fees shall be accepted with fine of **Rs.50/- per day up to 07<sup>th</sup> March, 2024**. Thereafter no fee shall be accepted and the name of such student shall be struck off from the rolls of the School. However, such student may be **re-admitted up to 15<sup>th</sup> March, 2024, on payment of Rs.4,000/- as re-admission charges along with the prescribed fees and fine**, with the prior approval of the competent authority of the School.


