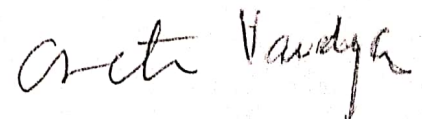
The Department of Personnel and Training has introduced a RTI Online Portal as the expansion of Right to Information (RTI) under Management Information System. Training Workshop on RTI Online Portal organised for the Public Authorities under Dept. of Higher Education has been attended by the Officers nominated by School as per the instruction of the MHRD vide its letter Ref. No. 11-3/2016-TS.VI dated 21.02.2017. Now, it has become mandatory to maintain this Online web portal for managing the application received online as well as offline.

A training session on "RTI ONLINE PORTAL" was organised in the School on Friday 14th July 2017 for designated Public Information Officers (PIO's) and First Appellate Authority (FAA's) nominated in the School to educate and implement the online RTI portal in SPA. The Faculty and staff who were directly or indirectly dealing with the RTI matter also invited to attend the above workshop.

The USER ID for the Nodal Officer had already been created for School by RTI Project Monitoring Unit (PMU) set up by DoPT. The PMU is coordinating with all Ministries and PA's under them and monitoring the online RTI portal. Online application received by Nodal Officer and will be forwarded to the concerned PIO's/FAA for further necessary action.

Under Master Updation the USER ID's have also been created for all the PIO's and FAA's designated in the School. The details of the same is enclosed for further necessary action. **All the PIO's and FAA's** are required to login the online portal **on daily basis** at the link "<https://rtionline.gov.in/RTIMIS/login/index.php>" with their USER ID and Password provided to them **to attend/reply the RTI applications and appeal received** in the School.

It is important and urgent to follow the time line as per the RTI Act, 2005 being a time bound requirement for reply/compliance of the RTI queries **failing which penalties can be imposed on the concerned PIO's/FAA's as per RTI Act, 2005.**
