Terms of Reference:

- Anti-Ragging Squads will maintain vigil, oversee and patrolling functions and their mobile phones shall remain on alert and active at all times.
- Anti- Ragging Squads will make surprise raids in hostels and other places vulnerable to incidents of and having the potential of ragging and is empower to inspect such places at all times.
- Anti- Ragging Squads will conduct on the spot enquiry into any incident of ragging referred to it by the Head of the institution / faculty members/ staff members/ students/ parents/ guardian/ employee of any service provider/ any other person, as the case may be, and the enquiry report along with recommendations shall be submitted to the Anti- Ragging Committee for action.
- Anti-Ragging Squads shall conduct such enquiry by observing a fair and transparent procedure along-with the principles of natural justice, and after giving adequate opportunity to the students accused of ragging, and other
- witnesses to place before it the facts, documents and views concerning the incident of ragging, and considering such other relevant information as may be required.
- The Chairperson of Anti-Ragging Squads of the particular building/complex (where an incident has occurred), shall proceed to file a First Information Report (FIR), within twenty four hours of receipt of such information or recommendation, with the police and local authorities under appropriate penal provision as per Clause 7 of UGC Regulations and continue with internal enquiry under Clause 9 of these regulations and other measures, without waiting for action on the part of the police/local authorities and such remedial action shall be initiated and completed and in no case later than a period of seven days of the reported occurrence of the incident of ragging, with intimation to the Chairman, Anti-Ragging Committee of the school.
