In case of no response, DG can be approached and intervention can be taken from MHRD. Other works as being considered in this BWC meeting can also be included in the proposal.

06 BWC ITEM NO. 3: PROVIDING AND FIXING G.I. CHAIN LINK FABRIC FENCING AT PLANNING CAMPUS ITO NEW DELHI -02.

The Committee modified terms and conditions and added 1% for electricity charges, in addition to 1% water, to be deducted from the bill.

However, during the discussions, Member from MHRD advised that the difficulty in procumbent through GeM can be sent to CEO, GeM. The items which are not included so far, can be added by GeM, including name of vendors.

The Committee after deliberations considered the proposal and approved the work of providing and fixing G.I.Chain Link fabric fencing at Planning Campus of the School at the estimated cost of Rs.2,45,232/- The work to be done as per GFR and CVC guidelines in this respect.

06 BWC ITEM NO. 4: MISCELLANEOUS REPAIR WORKS AT ARCHITECTURE & PLANNING BUILDING AT ITO CAMPUS, NEW DELHI-02.

Approval was accorded by BWC subject to verification that this work and the works approved in earlier BWC meetings are within PAR of maintenance norms of CPWD. If this amount is less than the norms, then only work be taken up by the School.

It was suggested that the limit of PAR Maintenance Norms can be got approved by the BWC and FC in principle, by BWC so that regular budget can be set aside as a routine.

06 BWC ITEM NO. 5: IMPROVEMENT OF DRAINAGE SYSTEM OF PLANNING BUILDING

BWC considered the item and approved it, in principle. BWC recognized that the work needs to be taken up as the drainage problem is a nuisance for the hostel occupants. Committee advised that the case should be sent to CPWD with a request to undertake entire work, including design and construction. CPWD may be asked to submit the cost estimate so that the same can be considered in the next BWC. The request for this item should be included with the other item decided to be taken up through CPWD.

06 BWC ITEM NO. 6: PARTITION WALL AT BOYS HOSTEL ABOVE HOSTEL MESS M.B COMPLEX NEW DELHI-02

The Committee considered and approved the construction of partition wall in the hostel at the estimated cost of Rs.68,681/-. The work shall be carried out as per GFR and CVC guidelines in this Meeting.

06 BWC ITEM NO. 7: REUSE OF SWIMMING POOL AREA AT THE SPA RESIDENTIAL COMPLEX AS A VOLLEYBALL /BADMINTON COURT

The BWC approved the item and advised that the obsolete plant room equipment of swimming pool should be sold out as a scrap. The item of scrap disposal of plant is to be added in the estimate as a buy back item. Fly ash must be substituted for filling. Cost recovery of scrap and fly ash would reduce the estimated cost. The Committee advised that existing boundary wall may not be broken and retained. Accordingly, revised estimate be prepared deleting this relevant items. The committee approved the above item at the maximum estimated cost of Rs.4,44,659/-, revising cost as advised above. The work is to be done as per GFR and CVC guidelines.
