In the recent 09<sup>th</sup> BOG meeting of the School held on 14<sup>th</sup> September, 2020, under Any Other Item, it was discussed that the conduct of Interviews for Professors in the School is getting delayed and the same should be expedited and carried out, if required, in an online / hybrid mode.

2. In this connection, the matter was discussed in detail but however, no decision could be taken and it was suggested that a complete proposal in this regard be prepared and circulated to all BOG Members, in due course, for finalizing the same, by circulation.

3. In this connection, the status of applications for various positions is brought to the kind notice of BOG Members:

4. It can be seen from the above table that a majority of the candidates are from Delhi.

6) Also, it may be noted that even in the past, in many interviews in the School, Skype online interviews with candidates were being conducted when a candidate is unable to come in person, for whatever be the reason.

7) This is a well-accepted widely prevalent practice in many Institutions in the country including SPA, Delhi.

8) Very recently, SPA-Bhopal has conducted its interviews in an Online Mode.

9) Therefore, in view of the above, it is proposed that since a majority of the candidates as well as the Selection Committee Members are from Delhi, the interviews may be held in the School Campus at Delhi and the few candidates/Selection Committee Members who cannot come to Delhi can participate through online mode.



10) Further, it is also proposed that the willingness from the candidates shall be obtained before conducting the interviews.


