Detailed deliberations were held. One Member of the Board informed the outcome of personal hearing he has given to Ms.Moulshri Joshi as per the earlier discussions held on this agenda item in the 16<sup>th</sup> BOG Meeting and he updated about the contention of Ms.Moulshri Joshi about the outstanding amount mentioned in the letter of acceptance of her resignation dated 10.09.2018.

It was also noticed that in the inquiry report under charge No.(III) is also partially proved.

While discussing all these facts, it was noticed that demurrage charges have been calculated from 2.11.2017 till the date of vacating the house i.e. 1.7.2018 whereas her resignation was communicated on 10.09.2018. She vacated residential accommodation before receipt of letter regarding acceptance of her resignation letter which was issued vide Ref. No.F.250/MJ/SPA(Estt.I) dated 10.09.2018.

The amount included in total outstanding dues on account of the demurrage charges was Rs.3,49,719/-. Members discussed about the provisions available for retention of house even in case of retirement and as per the existing practice, 4 months retention is allowed at the retirement. So, it was agreed that this 4 months may be allowed to her also and the demurrage charges may be recalculated accordingly. After the recalculation of the demurrage charges due and drawn statement may be re-prepared and outstanding amount to be received/paid may be

settled. Thereafter, clearance/settlement of dues, her resignation may be accepted as decided in the earlier BOG in its meeting held on 7<sup>th</sup> June, 2018 vide Resolution No.26. She may be relieved from the services of the institute accordingly.
