To understand the reasons and the necessity to appoint such a large number of Guest/Visiting faculty, the academic audit may be

conducted. The BOG authorised the Chairperson, BOG to constitute a committee to conduct such audit. The report of the committee shall be submitted to the Board for its consideration.

2. It was also brought to the notice of the BOG that there is a need for administrative reforms and to relook the administrative structure and its simplification and also to relook into the merger or realignment of the departments & other academic structures. The BOG authorised the Chairperson, BOG to constitute an Expert Committee and also to decide Terms of Reference (ToR) for the said Committee.
