- 2. E-Mail Photocopy of Fee Receipt immediately after Fee Payment to accounts@spa.ac.in.
- 3. Last Date for deposit of fees is 15th February, 2025.
- 4. In case any of the students fails to deposit his/her prescribed fee by 15th February, 2025, the late fee shall be accepted with a fine of Rs. 50/- per day up to 25th February, 2025. Thereafter no fee shall be accepted and name of the such student shall be struck off from the role of the School. However, such student may be re-admitted up to 04th March, 2025, on payment of Rs. 4,000/- as a re-admission charge along with prescribed fee & fine, with the prior approval of the Competent Authority of the School.
