

1. In the **REMARKS** column of NEFT, please mention Name of the Candidate & Course & also obtain transaction ID/UTR number after successful payment in the bank.
2. Please inform the School by email accounts@spa.ac.in & admission@spa.ac.in attaching a printout of the NEFT receipt having transaction ID/UTR number provided by the bank while depositing fee through NEFT, with your name, course for which selected and application number immediately after the NEFT payment.
3. If any student fails to comply with the condition no. 2 mentioned above, his/her fee may not be considered.
4. Last Date for deposit of fees is **07th September, 2020**.
5. In case any of the students fails to deposit his/her prescribed fees by 07th September, 2020, the fees shall be accepted with fine of Rs.50/- per day up to 18th September, 2020. **Thereafter no fee shall be accepted and the name of such student shall be struck off from the rolls of the School.** However, such student may be re-admitted up to 25th September, 2020, on payment of Rs.4,000/- as re-admission charges along with the prescribed fees and fine, with the prior approval of the competent authority of the School.
6. All the students are required to submit the proof of fees paid in their concerned Department of Studies for making entries in the Fee Collection Register. On completion of the register, the concerned Departmental official shall submit the register to his/her Controlling Officer for verification as the same is auditable.
