3. If any student fails to comply with the condition no. 2 mentioned above, his/her fee may not be considered.



In case any of the students fails to deposit his/her prescribed fees by 07th September, 2020, the fees shall be accepted with fine of Rs.50/- per day up to 18th September, 2020. **Thereafter no fee shall be accepted and the name of such student shall be struck off from the rolls of the School.** However, such student may be re-admitted up to 25th September, 2020 on payment of Rs.4,000/- as re-admission charges along with the prescribed fees and fine, with the prior approval of the competent authority of the School.

All the students are required to submit the proof of fees paid in their concerned Department of Studies for making entries in the Fee Collection Register. On completion of the register, the concerned Departmental official shall submit the register to his/her Controlling Officer for verification as the same is auditable.

The Heads of the Departments of Studies are requested to ensure that all the students have paid their fees, etc. and if any student has not paid the fees, the same may please be brought to the notice of the Assistant Registrar (Accounts and Budget Section) latest by 28th September, 2020.

Sponsored candidates are also required to pay the fees and other dues as shown above by the due date(s), and claim the reimbursement, if any, from their sponsoring authority subsequently, as per the terms and conditions of their sponsorship through their concerned Department of studies.
