The selected HOSTEL ALLOTTEES to various Master's Degree Programmes and Under Graduate Programmes in the School for the Session 2023-24, **as per list displayed on the SPA, New Delhi website**, are required to pay the **Hostel Fee** to the School of Planning and Architecture, New Delhi through **SBI Collect** (See details below). The details of fees are as under:-

The above payment is to be made through the following mode: -


1. By visiting SPA, New Delhi Website www.spa.ac.in & clicking on online payment (SBI Collect) tab.
OR
2. By visiting SBI collect website - online.sbi.com → click on SB Collect → Accepting Term & Condition → Selecting NCT Delhi → Select SPA Delhi in educational institute.

Note: -

1. Students should ensure that they deposit **Hostel Fee only after Hostel Allotment**.
2. After getting confirmation from payment gate way take print out of the fee receipt.
3. E-Mail **Scanned copy/PDF of Fee Receipt** immediately after Fee Payment to accounts@spa.ac.in and hostelloffice@spa.ac.in.
4. Hostel Fee is to be paid online **within 07 days of display of the Hostel allotment list on the SPA, New Delhi website or issue of this fee notice whichever is later**, failing which the allotment will be cancelled.
5. **In case the candidate is not willing to avail of the allotment and cancels the same within a period of one month then in that case an amount of Rs. 2,500/- (Rupees Two Thousand Five Hundred Only) will be deducted and the remaining amount will be refunded. If the cancelation is done after a period of one month from the date of allotment then there shall be NO REFUND (Except for the security amount i.e. Rs. 6,000/-).**

All the students are advised to get in touch with the Honorary Warden/HOD of concerned Department of Studies before making payment. The students are also advised that the Hostel Fees is to be paid separately and it should not be merged with the School academic fee.
