**FEES NOTICE**  
**(DOCTORAL PROGRAMMES)**

All the existing Ph.D. Scholars of the School (except newly admitted in July, 2017 and Foreign nationals/NRI/PIO) are requested to pay the following fees and other dues for the academic session 2017-18 between 25<sup>th</sup> July, 2017 and 14<sup>th</sup> August, 2017 as per the detail given below:-

<b>1. Registration Fees</b> (Every student has to registered himself/herself at the beginning of session on making payment as Registration fee failing which his/her name would not be enrolled for the class he/she has been studying).	500/-	500/-
<b>2. Tuition Fees</b>	10,000/-	20,000/-
<b>3. Academic Support Fee</b> (Library/Audio-Visual/Computer Lab/Internet)	4,000/-	4,000/-
<b>4. Student's Activities</b> (Games Fee, Students Activities Fund, Students Magazine Fee, Students Association Fee)	1,600/-	2,600/-
<b>5. Students Aid Fund</b>	-	200/-

In case any of the students fails to deposit his/her prescribed fees by 14<sup>th</sup> August, 2017, the fees shall be accepted with fine of Rs.50/- per day up to 21<sup>st</sup> August, 2017. Thereafter no fee shall be accepted and the name of the such student shall be struck off from the rolls of the School. However, such student may be re-admitted upto 28<sup>th</sup> August, 2017, on payment of Rs.4,000/- as re-admission charges along with the prescribed fees and fine, with the prior approval of the competent authority of the School.

All the students are required to submit the proof of fees paid in their concerned Department of Studies for making entries in the Fee Collection Register. On completion of the register, the concerned Departmental official shall submit the register to his/her Controlling Officer for verification as the same is auditable.

The Heads of the Departments of Studies are requested to ensure that all the students have paid their fees, etc. and if any student has not paid the fees, the same may please be brought to the notice of the Registrar/ Controller of Examination latest by 31<sup>st</sup> August, 2017.
