In case any of the students fails to deposit his/her prescribed fees by 16th January, 2020, the fees shall be accepted with fine of Rs.50/- per day up to 31st January, 2020. Thereafter no fee shall be accepted and the name of such student shall be struck off from the rolls of the School. However, such student may be re-admitted up to 10th February, 2020, on payment of Rs.4,000/- as re-admission charges along with the prescribed fees and fine, with the prior approval of the competent authority of the School.
