i)	PASS	Student is passed and promoted to the Next semester
ii)	C. O.	C.O. means Carry Over. The student is promoted to the next semester or year with Carrying Over Scheme as per rule 14.1 & 15.2 of the ordinance no.1.
iii)	WITHHELD	Result is withheld due to some specific reason and will be declared after the decision of Moderation Committee later on.
iv)	Failed as per rule	A minimum of grade "D" is required to earn assign credits of any course on the basis of internal assessment and/or external examination as the case may be for 10 and IE courses respectively, whether it is a <b>Theory paper or Jury or Viva-voce</b> . A student not passing the course shall be awarded grade "F" and declared failed in that course.
v)	Failed as per rule 11.1	A student declared failed with a "F" grade in any Jury examination, other than Thesis/Dissertation, shall not be promoted to the next higher year The student shall repeat the studio course along with the regular students in a subsequent academic year.
