The BOG deliberated at length on the issue of non-promotion faced by the faculty members in one of the best Institutes of the country since 1.1.2016. It was also informed that the revised Recruitment Rules are also pending with the Ministry since 2018. The revised report submitted by the Committee constituted for the purpose of resolution of the matter was also deliberated upon.

On this, it was informed by the Members, MOE that there is some contradiction in the Orders issued for the 6th CPC and the 7th CPC by the MOE. The matter is already taken up with the concerned Ministry for clarification in this regard since 12th March, 2019. The matter regarding approval of revised RRs is also under process. The MOE Representatives informed that observation of the Ministry on the committee report will be sent to the SPA expeditiously. It was also assured that clarification on continuation of CAS/Accelerated Promotion Benefits Scheme will be expedited.
