HOSTEL FEE NOTICE NEW & OLD STUDENTS (2025-26)

The selected HOSTEL ALLOTTEES to various Master's Degree Programmes and Under Graduate Programmes in the School for the session - 2025-26, as per the list displayed on the SPA, New Delhi website, are required to pay the Hostel Fee to the School of Planning and Architecture, New Delhi through SBI Collect. The details of fees are as under:-

The above payment is to be made through the following mode:-

- A) By visiting SPA, New Delhi website <u>www.spa.ac.in</u> (SPA, Delhi website) & Click on Educational Institutions -Click on School of Planning and Architecture, Delhi.
- By visiting SBI Collect website Click on Educational Institutions Click on School of Planning and Architecture,
 Delhi.

Note:-

- 1) Students should ensure that they deposit Hostel Fee only after Hostel Allotment.
- After getting confirmation for the payment gateway, students are advised to take printouts of fee receipts and also keep the soft copy in PDF format.
- 3) The students shall submit the scanned PDF / Soft copy of the Fee Receipt immediately after Fee payment to accounts@spa.ac.in / hosteloffice@spa.ac.in / admission@spa.ac.in .
- 4) Hostel Fee is to be paid online within 07 days of display of the Hostel allotment list on the SPA, New Delhi website, failing which the allotment will be cancelled.
- 5) In case the candidate is not willing to avail of the allotment and cancels the same within a period of one month then in that case an amount of Rs. 2,500/- (Rupees Two Thousand Five Hundred Only) will be deducted and the remaining amount will be refunded. If the cancellation is done after one month from the date of allotment then there shall be NO REFUND (Except for the Security amount i.e. Rs. 6,000/-).

All the students are advised to get in touch with the Honorary Warden/HOD of the concerned Department of Studies before making payment. The students are also advised that the Hostel Fees is to be paid separately and it should not be merged with the School Academic fee.
