All the Self Financing students i.e. Non-Indian Residents and Persons of Indian Origin (FN/NRI/ PIO/CIWG) already enrolled, III Semester to IX Semester & Repeaters of I Semester of Bachelor's Degree Courses (Bachelor of Architecture and Bachelor of Planning) and Master's Degree Courses are required to pay the following fees in US\$ for the Academic Session 2025-26, as under:-

3. If any student fails to comply with the condition no. 02 mentioned above, his/her fee may not be considered.

If any student fails to deposit his/her prescribed fees by **04th August, 2025**, the fees shall be accepted with a fine of **Rs. 50/- per day** up to **14th August, 2025**. After that, **no fee will be accepted and the name of such a student will be struck off from the rolls of the School**. However, such student may be **re-admitted up to 25th August, 2025**, on payment of **Rs.4,000/-** as re-admission charges along with the prescribed fees and fine, with the prior approval of the competent authority of the School.

All the students are required to submit proof of fees paid in their concerned Department of Studies for making entries in the Fee Collection Register. On completion of the register, the concerned Departmental official shall submit the register to his/her Controlling Officer for verification as the same is auditable.

The Heads of the Departments of Studies are requested to ensure that all the students have paid their fees, etc., and if any student has not paid the fees, the same may please be brought to the notice of the Assistant Registrar of the Accounts and Budget Section & Assistant Registrar of the Admission Section latest by **01st September, 2025**.
