3. Last Date for deposit of fees is **24<sup>th</sup> August, 2025**.
4. If any student fails to deposit his/her prescribed fees by **24<sup>th</sup> August, 2025**, the fees shall be accepted with a fine of **Rs. 50/- per day up to 03<sup>rd</sup> September, 2025**. After that, no fee will be accepted and the name of such a student will be struck off from the rolls of the School. However, such student may be re-admitted up to **12<sup>th</sup> September, 2025**, on payment of **Rs.4,000/-** as re-admission charges along with the prescribed fees and fine, with the prior approval of the competent authority of the School.
