The selection of the candidates through Direct Admission of Students Abroad (DASA 2025) for the Bachelor's Degree Programs in Architecture/Planning in the School for the session 2025-26. The following certificates/fee receipts (self-attested) and testimonials may be produced for verification to officials of the school on all working days as per the DASA schedule from the date mentioned on the SPA, website:-

- 1. Self-Attested Photograph
- 2. Application Form (To be downloaded from website of SPA, New Delhi) should be duly filled up with self-attested photographs.
- 3. Proof of Fee Receipt of First Semester, paid to DASA and balance fee paid to SPA, New Delhi.
- 4. Copy of Admit Card and Provisional Admission letter issued by the DASA.
- 5. Copy of Rank Card for the DASA/SAT/JEE-2025.
- 6. Copy of Applicant's Passport (Nationals of Nepal who do not have a passport, copy of Authenticated Citizenship Card has to be submitted).
- 7. Proof for date of birth (Secondary Education Board / University Certificate [Class X or equivalent] or any certificate issued by the concerned Government authorities).
- 8. Copy of Mark Sheet of 10th, 11th and 12th (or) Equivalent examination(s).
- 9. Certificate from School authorities (in the format given in Appendix-II on letter head of the school) as proof of completion of 11th and 12th Standard or equivalent.
- 10. Percentage/CGPA equivalence provided by the principal examination authorities, in case CGPA on a different scale than that specified is awarded OR if only grades are awarded.
- 11. Proof of 2 years of education (11th and 12th or equivalent) in foreign country in case of NRI (School leaving certificate/Mark sheets/Study Certificate as in appendix IV).
- 12. Latest Character Certificate issued by the institution last attended.
- 13. Latest Physical Fitness Certificate from the MBBS Doctor
- 14. Anti-Drugs Undertaking
- 15. Anti-Ragging affidavits from student and parents/guardians
- 16. Undertaking
- 17. Candidate selected under CIWG quota, has to produce following documents in addition to the above mentioned:
 - Copy of the passport of the parent working in the gulf.
 - Copy of Parent's Visa with validity on any date in the year 2025.
 - Copy of Parent's Work Permit with validity on any date in the year 2025.
 - Certificate from the company/organization as proof that parent is working in gulf country as per Appendix III of UG Brochure

- 1. The first semester fee in total to be paid by the student is given below.
- 2. Students are required to pay the balance fee after deducting the fee deposited with DASA as per the DASA Schedule (Excluding DASA registration fee i.e. **US\$300**).
