All Indian students of II Year-III Semester, III Year-V Semester, IV Year-VII Semester, V Year-IX Semester, and Repeaters of the First to Fifth Years of the Bachelor's Degree Course in Architecture / Planning in the School are required to pay the following Fees and Other Charges for the Academic Session 2026-27 till 7th August, 2026, as per the detail given below:-

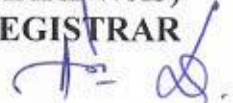

If any student fails to deposit his/her prescribed fees by 7th August, 2026, the fees shall be accepted with a fine of Rs.50/- per day up to 17th August, 2026. After that, no fee will be accepted and the name of such a student will be struck off from the rolls of the School. However, such student may be re-admitted up to 24th August, 2026, on payment of Rs.4,000/- as re-admission charges along with the prescribed fees and fine, with the prior approval of the Competent Authority of the School.

All the students are required to submit proof of fees paid in their concerned Department of Studies for making entries in the Fee Collection Register. On completion of the register, the concerned Departmental official shall submit the register to his/her Controlling Officer for verification as the same is auditable.

The Heads of the Departments of Studies are requested to ensure that all the students have paid their fees, etc., and if any student has not paid the fees, the same may please be brought to the notice of the Assistant Registrar of the Accounts and Budget Section & Assistant Registrar of the Admission Section latest by 28th August, 2026.
