2. Please inform the School by email to accounts@spa.ac.in & admission@spa.ac.in attaching a printout of the NEFT Receipt having transaction ID, provided by bank while depositing fee, through NEFT with your name, course for which selected and application number immediately after the NEFT payment.

NOTE: If it is found that any false / invalid or forged document/certificate submitted by the candidate with respect to eligibility at any stage of studying the Course, his/her Admission will be **Cancelled** without any notice and no refund of any Fees shall be made.

Note:

1. Attach Photocopy of the Receipt of Fee Payment.
2. E-Mail Photocopy of Fee Receipt immediately after Fee Payment to accounts@spa.ac.in & admission@spa.ac.in.
3. The Last Date of payment of Fees is 7th August, 2026.
4. If any student fails to deposit his/her prescribed fees by **7th August, 2026**, the fees shall be accepted with a fine of **Rs.50/- per day** up to **17th August, 2026**. **After that, No Fee will be accepted and the name of such a Student will be struck off from the rolls of the School.**

However, such student may be **re-admitted themselves up to 24th August, 2026**, on payment of **Rs.4,000/-** as Re-admission Charges along with the prescribed Fees and Fine, with the prior approval of the Competent Authority of the School.
