Applications are also invited for:- (1) PG seats for Wards of Kashmiri Migrants / Kashmiri Pandits / Kashmiri Hindu Families (Non - Migrants) living in Kashmir Valley are reserved as per the Central Government norms. (2) PG seats for Physically Challenged Persons, on a horizontal basis these will be adjusted against the respective reservations for OG, SC, ST and OBC Categories as per the Central Government norms.						

NOTE:- Fee for PG (Spot-Round) Form:-

- A) **Rs.3,500/-** for candidates except SC/ST Candidates & **Rs.1,750/-** for SC/ST Candidates.
- B) JAAP-PG Registered candidates - Exempted.

General Note: There is very limited Hostel Accommodation and aspirants are to be aware of the fact that they may not get Hostel Accommodation.

ELIGIBILITY: -

Candidates shall be eligible for admission to the First Year of the various Post Graduate Degree programmes if they have obtained a minimum of 55% marks or 6.0 CGPA and 50% marks or 5.5 CGPA for the reserved categories SC/ST/ PwD in the qualifying examination, for each of the programmes respectively, as given below:

Master of Architecture (Architectural Conservation)

Bachelor's Degree in Architecture or Planning or Civil Engineering from a recognized University or Master's Degree in History/ Cultural Studies/ Heritage Studies/Anthropology or equivalent or Master's Degree in Museology/ Archeology or equivalent from a recognized University or PG Diploma (two years) in Archeology / Museology/Conservation or equivalent from a recognized University or 5 year integrated Degree in Law with specialization in Heritage Law from a recognized University. Candidates from non-architectural courses need to earn additional credits as prescribed and notified separately

Master of Architecture (Landscape Architecture)

Bachelor's Degree in Landscape Architecture or Architecture or Planning or Civil Engineering from a recognized University or Bachelor's Degree in Interior Design or Urban Design disciplines with at least four full-time academic years in duration from a recognized University or Master's Degree in Botany or Zoology or Horticulture or Agriculture or Forestry or Ecology or Geology or Geomorphology or Geography from a recognized University. Candidates from Non-Architectural courses need to earn the additional credits as prescribed and notified separately.

Master of Architecture (Urban Design)

Bachelor's Degree in Architecture or Planning from a recognized University.

Master of Building Engineering and Management

Bachelor's Degree in Architecture or Planning or Engineering (Civil Engineering / Building Engineering / Architectural Engineering / Building Science / Building & Construction Management / Construction Technology / Construction Engineering & Management / Construction Technology & Management) from a recognized University or Five-Year Diploma in Construction Engineering & Management / Construction Technology & Management from a recognized University.

Master of Design (Industrial Design)

Bachelor's Degree in Architecture or Engineering or Planning from a recognized University or Bachelor of Design / GDPD / Bachelor of Fine Arts (BFA) (with 1-year Experience) from a recognized University or Master of Fine Arts (MFA) from a recognized University with a valid CEED score (essential for non-architectural candidates) from approved streams.

Master of Planning (Environmental Planning)

Bachelor's Degree in Architecture or Engineering (Civil / Environmental Engineering) or Planning from a recognized University or Master's Degree in Geography/ Economics/ Sociology/ Environmental Science / Environmental Management from a recognized University or 5-year integrated Degree in Law with specialization in Environmental Law/ General Law from a recognized University.

Master of Planning (Regional Planning)

Bachelor's Degree in Planning or Architecture or Civil Engineering or Architectural Engineering from a recognized University or Master's Degree in Geography / Economics / Sociology from a recognized University or equivalent.

Master of Planning (Urban Planning)

Bachelor's Degree in Planning or Architecture or Civil Engineering or Architectural Engineering from a recognized University or Master's Degree in Geography / Economics / Sociology from a recognized University or equivalent.

Master of Planning (Transport Planning)

Bachelor's Degree in Planning or Architecture or Civil Engineering from a recognized University or Master's Degree in Geography / Economics / Statistics / Operations Research from a recognized University.

Master of Planning (Housing)

Bachelor's Degree in Planning or Architecture or Civil Engineering or Architectural Engineering or Municipal Engineering or Building Engineering from a recognized University or Master's Degree in Geography / Sociology / Economics from a recognized University or equivalent.

SELECTION CRITERIA:

The candidates are required to appear before the Selection Committee for Admission for Interview in person (Offline Mode Only).

- 1) Performance in Qualifying Examinations;
- 2) Valid GATE/CEED/UGC NET Score
- 3) Interaction
- 4) Statement of Purpose (description of the interest and motivation for the chosen study) Work experience, if any, after attaining the eligibility qualification. Based on the performance in the interaction, performance in the above-mentioned criteria, the merit list of the selected candidates will be uploaded on the SPA, New Delhi website (www.spa.ac.in) under Tab **ADMISSION 2026-27**.

MARKS:

Candidates with at least 55 percent marks in aggregate in the qualifying examination and 50% aggregate marks in respect of SC/ST/OBC.

APPLICATION FORM (PG PROGRAMMES):

Eligible candidates may submit a filled-in Application Form through the link provided on the School's website www.spa.ac.in, along with requisite self-attested documents to be uploaded on the Google form except for portfolio & thesis. Applicant SHALL APPLY in only the course of his/her choice.

GENERAL INSTRUCTIONS:

An applicant can apply for any programme as per eligibility. The application fee for the PG programme is **Rs.3,500/- for all except SC/ST Candidates & Rs.1,750/- for SC/ST Candidates, (Non-Refundable)** to be paid **online through the SPA, New Delhi, website at www.spa.ac.in (SBI Collect)**. Those Candidates who have paid fee during registration through JAAP - PG 2026 need not to pay Application fee for SOPT Round. JAAP - PG 2026 application number must be filled into the Application form. Also Candidates participated in JAAP PG 2026 must mention the JAAP-2026 Application number in the SPOT Round Application.

Admission to Post Graduate courses against Kashmiri Migrant Reserved Seats:

15 seats will be reserved over and above the total number of PG seats for Wards of Kashmiri Migrants / Kashmiri Pandits / Kashmiri Hindu Families (Non-Migrants) living in Kashmir Valley.
