(FIRST SEMESTER) - REPORTING GUIDELINES**

The selection of the candidates through "Direct Admission of Students Abroad" - DASA & JoSAA - 2026 for the Bachelor's Degree Programs in Architecture/Planning in the School for the session 2026-27. The following Certificates/Fee Receipts (self-attested) and testimonials may be produced for verification to officials of the school on all working days as per the DASA schedule from the date mentioned on the SPA's website:

1. The **Application Form** (to be downloaded from the SPA, New Delhi website) should be duly filled out **with self-attested photographs**.
2. Proof of **Fee Receipt** paid to DASA and balance Fee to be paid at the time of Physical Documents Verification at SPA, New Delhi.
3. Copy of **Admit Card** and Provisional Admission Letter issued by the DASA.
4. Copy of **Rank Card** for the **DASA/SAT/JEE-2026**.
5. Copy of **Applicant's Passport** (Nationals of Nepal who do not have a passport, copy of Authenticated Citizenship Card has to be submitted).
6. **Proof for Date of Birth** (Secondary Education Board / University Certificate [Class X or equivalent] or any certificate issued by the concerned Government Authorities).
7. Copy of **Mark Sheet of 10th, 11th and 12th (or) Equivalent examination(s)**.
8. **Certificate** from School authorities (in the format given in Appendix-II on letter head of the School) as **proof of completion of 11th and 12th Standard** or equivalent.
9. **Percentage/CGPA** equivalence provided by the principal examination authorities, in case CGPA on a different scale than that specified is awarded OR if only grades are awarded.
10. **Proof of 2 years of education (11th and 12th or equivalent) in foreign country in case of NRI** (School Leaving Certificate/Mark Sheets/Study Certificate as in Appendix-IV).
11. **Latest Character Certificate** issued by the Institution last attended.
12. **Latest Physical Fitness Certificate from the MBBS Doctor**.
13. **Anti-Drugs Undertaking**.
14. **Anti-Ragging affidavits from Student and Parents/Guardians**.
15. **Undertaking from Student**.
16. Candidate selected under **CIWG quota**, has to produce following documents in addition to the above mentioned :
 - Copy of the Passport of the parent working in the Gulf Countries.
 - Copy of Parent's Visa with validity on any date in the year 2026.
 - Copy of Parent's Work Permit with validity on any date in the year 2026.
 - Certificate from the company/organization as proof that parent is working in gulf country as per Appendix-III of UG Brochure.
